DEVELOPMENT WORKING GROUP

A meeting of the above group was held at 3:30 pm. on 22 March at the Sedos Secretariat.

- 1. The Chairman welcomed back to the Group Fr. Bundervoet and Sr. Helena who had been away on visitation. For their benefit she gave a sesume of the work undertaken by the Group between November '73 and February '74. She then extended a warm welcome on behalf of all those present to Sr. Melanie Fernando who had undertaken to give the meeting a first hand account of the rural-urban continum situation in Sri Lanka. As the Holy Family Sisters had over 300 members in that country, she was in a position to speak with considerable authority on conditions prevailing there.
- 2. Sr. Melanie explained that the population of Sri Lanka was over 80% rural in character but due in great part to the economic system and the type of education—largely academic—which had prevailed until recently more and more people were crowding into the cities. While some obtained jobs many more could not obtain the sort of employment for which their education suited them. Furthermore there was simply not enough housing to cope with the influx of new city and town dwellers. Youngsters who went to the cities seeking education (even at University level) usually had to live in sub-standard accommodation. And when they graduated many of Sri Lanka's brightest products left the country.

In the rural areas there were also difficult problems to be faced. The traditional rural framework had been disrupted by modern economic trends which had tended to encourage the growing of cash crops at the expense of food. The result was that at the moment there was a serious shortage of exen basic foodstuffs. There was still much fertile land available but it needed to be cleared. The government was trying to deal with the enormous problems facing the country and the Church was doing what it could to cooperate with its plans. Previous to 1961 the bulk of the HFC Sisters had been engaged in education but in that year all schools were nationalized. Officially the Church had objected to the takeover but in fact many of the Sisters and other Religious had remained on in the schools. Indeed they are playing a prominent part in the government's campaign to reorganize the educational system along more practical lines by the introduction of subjects such as basic agricultural science, handicrafts etc. Others (including some compulsorily retired by reason of age) turned to alternative forms of educational and social apostolate. It was now recognized that nationalization had been a blessing in disguise, compelling the Church to rethink her priorities and basic strategy. Not that formal edu-ational work was downgraded--if anything those involved in teaching had to take on more catechetical and youth-orientated work than before - but greater attention was given to other areas of activity which had

hitherto comparatively-speaking been neglected.

Many of the Sisters and other Religious are engaged in the usual works involving the care of the sick, the aged and orphans. Others again have become deeply involved in various forms of apostolate among the rural poor, especially among the tenant-labourers (mostly of Indian origin) of the great tea and rubber plantations. Though stateless these people have a very strong community spirit and the Sisters find they can operate very effectively through this. Their work involves helping these people in the fields of adult education of a practical nature, health care and catechetics. The Sisters in the rural areas live the simple, frugal life of the people aomong whom they are working. Some have gone to the new agricultural colonies established by the government in the forest areas now being cleared for cultivation. In places where the caste system still prevails the Sisters are doing what they can to gradually eliminate this form of prejudice and are helping girls belonging to the lower castes to overcome this disadvantage. This is necessarily a very deli ate type of operation.

The HFC are also helping to staff Sedec, an organization for social and economic development, which aims at channelling aid from abroad into projects which hopefully, will help slow down the exodus from the countryside into the larger towns e.g. small scale industries such as weaving, poultry rearing and cigar making. There is much to be done also in the field of the parish apostolate. The Sisters are giving invaluable aid to the parochial clergy particularly by family visitation and conducting catechetical courses. They are conscious at all times of the necessity for keeping in contact with school leavers as there is a danger of losing the next generation by concentrating too much on the adults. Youth needs are also being catered for in the urban setting by a group of Sisters who have established a couple of hostels for secondary school and university students. Bro. Gottwald intervened at this point to stress the importance of this work since large numbers of students were compelled to live and study in dreadful conditions. Sr. Melanie agreed that the problem was a huge one and the Sisters realize only too well that much still remains to be done.

The general picture which emerged from Sr. Melanie's talk was of a dynamic, self-sustaining Church (with a minimal number of expatriate personnel), which not only preached but lived the Gospel. After some initial hesitation there was now friendly cooperation with government in programmes aimed at improving the conditions and quality of life throughout the country. When she was asked what the people of Sri Lanka wanted and expected from the Church Sr. Melanie listed the following:

- a) they want the Religious to remain in all forms of educational activity;
- b) Catholics want catechetical facilities (including those involving the training of lay catechists) extended;
- c) all classes and creeds are aware of the need for a revival of religious values; Christians were aware that they might be lagging behind in encouraging such a revival as compared to for example, the Buddhists and Hindus;
- d) there is a general desire for a better standard of living and better social services and it was hoped that in the latter sphere the Church (and the Sisters in particular) would play a useful auxiliary role.
- 3. <u>Fr. Moody</u> praised the stance taken by the Church in Sri Lanka vis-a-vis government policies. After some initial reluctance the Church had cooperated loyally with the

plans of the civil authorities. We must always be prepared to cooperate for the common welfare and make this desire for cooperation clear e.g. in school nationization schemes. The Church in Sri Lanka now realized that she had in fact derived considerable advantages from what seemed initially an unfavourable development. But we should not embarrass the state by anticipating nationalization measures for which it is not yet ready due to scarcity of manpower, money or management skills.

4. It was agreed that at the next meeting Sr. Mary Motte would read the paper (which she had already given to the Agrimissio - Cesta gathering at the FAO Headquarters) on "The Woman's Role in Rural Development". The Group would then discuss the paper and examine its relevance to the general thrust of its work.

The next meeting of the Group was arranged for 3:30 pm. on Tuesday, 9 April at the Sedos Secretariat (unless members were otherwise informed).

DOCUMENT OF SPECIAL INTEREST

"EVANGELIZATION IN EASTASIA TODAY - AN OVERVIEW"

The Federation Asian Bishops'Conferences (FABC) held their first regional meeting for East Asia at Fujen Catholic University, Taipei, Taiwan on August 26-31, 1973. The Secretariat of the Chinese Bishops'Conference of Taiwan, have now published a booklet (January 1974), giving an summary of the proceedings. (50 pp.).

In view of the I974 World Synod of Bishops, this publication is most timely. Using the Roman Document "The Evangelization of the Modern World" as a starting point, the Assembly faces the problem of bringing the Gospel of Christ to the modern East Asian. A review of the state of the Church in China, Japan, Korea and Vietnam affords a brief, accurate and authoritative presentation, based on the reports of participants in the Regional Assembly.

Position papers in the spirit of Vatican II were presented by delegates to the Assembly, These formed the basis of a fruitful dialogue, and were followed by Bishop Cheng's Progress Report on Theological Adaptation for the East-Asian region, which is basically a Confucian culture. Then come the General Conclusions, which have already received extensive publicity in international publications.

This booklet will expedite a fruitful dialogue in the Plenary Assembly of the FABC, which will be held in Taipei during the week of April 22, 1974.

Just one quotation from this tiny but densely packed 50-page booklet:
"If the Church is to become really credible in all that she affirms and teaches, she must bear witness to her own message by fully committing herself to making this world worthier of man through integral human development. This in no way deflects from her duty to show man his final destiny. On the contrary, it is perhaps the most convincing way to do so today, as well as to manifest in her own life, Jesus of Nazareth, our Brother".

"Here, perhaps, the Church in our countries would do well to address herself to the concerns and problems of people today, not from the stance of moralizing, but directly, in their full implications. In this way, the Church will identify herself with the people in their anguish and aspirations. She will thus reveal herself to be the incarnate Sign of Salvation." (p. 28).
